## Agreement Overview

This contract outlines terms for breeding the stud dog, with no guarantees of pregnancy or puppy production. A successful litter is defined as two live puppies surviving 48 hours post-whelping. If no litter is produced, the stud fee is not credited for future breeding, and a new fee applies. All fees are non-refundable.

- **Stud Fee Total:** \$2,800 (US)
    - **Non-Refundable Service Fee:** \$500, due at breeding
    - **Remaining Balance:** \$2,300, due upon litter birth
